A LETTER FROM OUR CEO

2023 ended with a historical milestone: the President of Zanzibar announced the institutionalization of **Jamii ni Afya**, the community health program that D-tree has supported since 2010. With resounding commitment, the government will improve the conditions for community health workers, including adequate remuneration and training so they can provide comprehensive health services at the doorstep of every Zanzibari household.

This achievement represents a significant step toward a healthier future. The foundation of good health starts in people's homes: the "first" mile of health and well-being. The tireless efforts of community health workers pave the way for healthier, happier lives and societies.

In 2023, D-tree continued to support primary healthcare in Zambia, Malawi and Tanzania by leveraging digital technology. I am proud that our work has contributed to over **640,000 health visits in 2023, which is a 15% increase from 2022**: more mothers, children and their families now benefit from quality healthcare.

Internally, we have continued to live our **organizational values**. One of our core values is diversity and last year, we increasingly included diverse voices and lived experiences in our decision-making. We are proud that our Board is composed of 40% Africans and 60% women. We are continuing to improve diversity across the organization, including in leadership roles.

Looking ahead, 2024 marks D-tree's 20th anniversary. In celebrating this milestone, we carefully assessed avenues to accelerate impact and refined our approach. **While we keep strengthening health service provision at the community level, we recognize that it is equally important to improve quality in health facilities.** People need different health services throughout their life and we will aim at improving health services and connecting and coordinating providers in a people-centered way. This will enable better decision-making and care provision throughout the health system and ultimately save lives.

Witnessing D-tree's 2023 results and planning for our future makes me proud, hopeful and even more committed to our cause. I am grateful to all of you who joined us to enhance access to quality healthcare for all. Thank you.

THE CHALLENGE: POOR ACCESS TO QUALITY HEALTHCARE

Millions of people die every year because they don't get the quality care they need, when and where they need it.

287,000 women worldwide die every year as a result of their pregnancy. 6.9 million under-five children die, of which about 3 million are newborns. Most of these deaths occur in sub-Saharan Africa.

43 in 1,000 children die before the age of five in Tanzania

39 in 1,000 babies die in their first month of life in Zambia

Malawi has an average life expectancy of only 61 years

In many low- and middle-income countries, health systems are fragmented and not centered around the needs of the people they serve, leaving many without sufficient access to essential healthcare. This is one of the biggest injustices the world is facing today. D-tree works to change that.

IMPROVING CARE FOR EVERYONE

We improve delivery of timely and quality care by introducing innovative tools for health workers across the system – from the community health worker to the health facility and drug shop. By expanding, training and equipping these key health providers we prepare systems to deliver quality care for all.

In 2023, we strengthened **Afya-Tek**, our flagship program in Tanzania improving maternal, child and adolescent health. The program connects patients to community health workers, drug shops and health facilities, ensuring timely and personalized care. The system is unique for its inclusion of private sector drug shops – a convenient and frequently utilized community access point accessed by over 70% of the rural population.

In 2023, Afya-Tek reached nearly 500 healthcare providers and 237,000 registered users, showing how successful this approach is in providing healthcare to those who might not go to health clinics or are reached by community health workers. 90% of patients are successfully followed up in health clinics for further care, which is three times higher than other health programs.

The digitally-enabled community health program **Jamii ni Afya**, supported by D-tree, continues to serve nearly every household in Zanzibar. In 2023, we worked with the Ministry of Health and leading early childhood development experts, to make early childhood development services available to all Zanzibaris as we expanded the community health workers' service delivery package, based on the World Health Organization's and Unicef's Nurturing Care Framework and adapted from Care for Child Development.

As community health workers visit people's homes, they now have the tools they need to observe caregiver-child interactions

and look for concerns such as harsh discipline, lack of play materials, health and nutrition or unsafe environments. Community health workers also coach caregivers on age-appropriate play and communication. In 2023, we partnered with the Ministry of Health to expand and improve how these services are delivered, so that more children can reach their full potential in Zanzibar:

Improvements to community health worker training and supervision approaches, including emphasizing community health workers' practical skills in coaching on early childhood development and incorporating videos into training sessions to demonstrate behaviors.

Community health workers have increasingly engaged fathers in caring for children, leading to more meaningful relationships between children and their fathers.

Improved guidance for children with disabilities so that those children needing support the most can thrive.

In Malawi, we have improved how HIV services are delivered in the community and at the health facilities. Alongside partners, we have designed, developed and piloted a digital solution supporting community health workers in providing people-centered HIV care. **Community health workers will be better equipped to support people with HIV to routinely attend their health visits and stay healthy throughout their lives** and also contribute to reducing new number of HIV cases. We are now focused on scaling the tool to help Malawi reach its 95-95-95 targets and ensure all people living with HIV get the support they need to lead healthy lives.

MAKING A LASTING IMPACT, TODAY AND FOR THE FUTURE

We build strong data-driven health systems that deliver quality care for all. We co-design our programs with governments while helping them build the necessary skills to take full technical, operational and financial ownership over the long term to achieve impact that last.

When Jamii ni Afya reached national scale in 2021, it transformed the Zanzibari health system and helped ensure that every family has access to high-quality care at its doorstep. In 2023, we reached a new milestone as we started to prepare the Revolutionary Government of Zanzibar to take full ownership of Jamii ni Afya. The commitment was solidified through the **Jamii ni Afya Transition Plan**, with 15% of operating costs already allocated in the 2023–2024 national budget. Political will is important for

sustainable change, and in December 2023, the President and the Minister of Health publicly declared themselves as champions of the program, bringing Jamii ni Afya into the national spotlight and affirming Zanzibar’s commitment at the highest levels.

Throughout Jamii ni Afya, we have learned a lot about how to successfully transform digital health systems, and last year we published a **report in JMIR** capturing our journey, including the many valuable lessons that other implementers can draw from when working on strengthening digital health systems across the world.

In Tanzania, D-tree partnered with the Government of Tanzania and others to build and implement the Ministry of Health’s national digital community health system. This high-quality and data-driven system will improve community health service delivery and expand access to quality care at health facilities. In 2023, D-tree integrated early child development services, adapted from Jamii ni Afya into the system making these services available to more Tanzanians than ever before. We also received government approval to bring Afya-Tek into this system, as the government values how Afya-Tek connects private-sector drug shops with public health services and improves data visibility and sharing across the entire health system. This national digital community health system has the potential to reach over 40 million people with quality healthcare, so more people than ever can live happier and healthier lives in Tanzania.

In 2023 we also strengthened national health systems in Malawi and Zambia. In Malawi, we collaborated with partners to realize the government’s vision for a national digital system that will guide community health workers in delivering diverse health services, while also making the resulting



data available at the community, district, and national levels. In Zambia, we entered a new partnership to support the Ministry of Health to show what the updated national community health system could look like

as D-tree is designing and developing digital tools to support Zambia’s community health workers to provide high-quality, patient-centered health services.

As we are moving into 2024, we are continuing this transition by...

Finding ways to improve the financial stability of the health system in Zanzibar by linking Jamii ni Afya to ongoing government efforts such as universal health insurance

Training the government and creating systems to manage the operational and technical components of the program with support from other organizations.

RIGHT CARE Trained health workers with digital tools improve diagnostic accuracy, and the availability of full data enables tailored health services, ensuring everyone receives the care they need.

RIGHT PLACE We connect the dots between community health workers, health facilities, and people. Care is delivered at the right level of the health system and is accessible to all people, wherever they are.

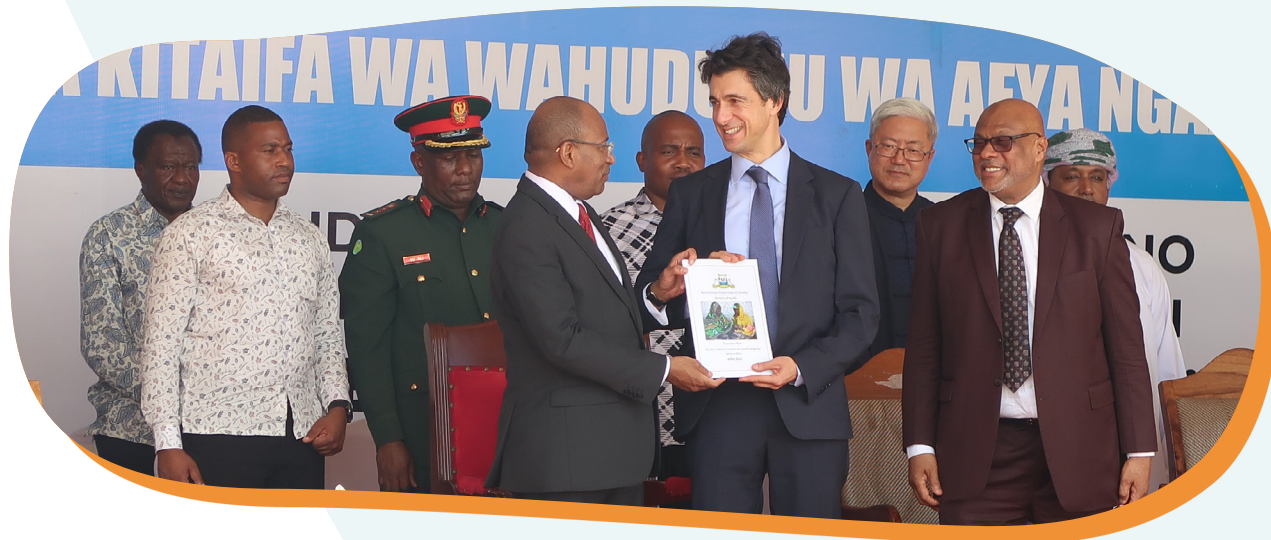

FROM VOLUNTEERS TO WORKERS

Major steps toward professionalization of the community health workforce in Zanzibar

Last year marked a historic milestone for Jamii ni Afya and the Revolutionary Government of Zanzibar who announced the transition of their national cadre of community health workers from community health volunteers to professional and salaried community health workers. This shift represents a profound step toward enhancing the impact and recognition of these vital contributors to the health sector.



We know that community health workers who are salaried, skilled, supervised and supplied have the potential to save millions of lives and we were proud to see the Revolutionary Government of Zanzibar taking big steps toward this last year. In December, the Ministry of Health upgraded Zanzibar's community health volunteers to community health workers, recognizing them as professionals and acknowledging their essential contributions to the health system. This milestone was celebrated at an event in December last year, bringing together community health workers from across the islands of Zanzibar, development organizations, and government ministries.

THE COMMITMENT

Jamii ni Afya community health volunteers will be officially called community health workers, recognizing their contribution to the Zanzibar health system as public health professionals.

The community health workers will become part of Zanzibar's national health system as an official workforce cadre.

The government will raise and commit domestic funds to sponsor the costs of the Jamii ni Afya program.

Community health workers will receive a compensation that is three times greater than their current stipend. The government will continue to utilize a pay-for-performance system to enhance community health workers accountability and commitment.

Community health workers will provide expanded services to households and communities, including simple curative and diagnostic services. Community health worker training will be strengthened to accommodate the added skills and knowledge needed.

We are proud to have worked hand-in-hand with the government to reach this milestone and will continue to build on this success in 2024 and beyond.

COMMUNITY HEALTH IMPACT COALITION

D-tree is a member of **Community Health Impact Coalition** (CHIC), a coalition including thousands of community health workers and dozens of health organizations in 60+ countries. Together, we are making professional community health workers the norm worldwide by influencing guidelines, funding, and policy. In 2023, we supported the proCHW movement with advocacy at the 76th World Health Assembly, where the Zanzibar Minister of Health, representing both Zanzibar and Tanzania, called for the transition of community health volunteers to professional workers. D-tree's engagement extends to national-level CHIC coalitions, such as in Malawi, where we contribute to advancing professional community health worker policies and practices.

INNOVATING WITH A PURPOSE
FOR THE PEOPLE WHO NEED IT
THE MOST

Increasing access to high-quality healthcare requires a sustainable approach to innovation. We develop context-specific solutions that are designed to be integrated into existing health systems and respond to the highest needs in the country.

In 2023, we continued to explore how artificial intelligence can improve the health and well-being of people, focusing on chatbot technologies and predictive models. Together with experts we prototyped innovative solutions for community health workers and experimented in making ChatGPT accessible for health education and promotion related to HIV. All of this helped us understand the potential and limitations of making similar services available in local languages.

We fostered discussions with other experts on the ethical use of artificial intelligence in development. At the Global Digital Health Forum, we co-facilitated a workshop on **implementing artificial intelligence in Low-Resource Healthcare Settings**. We also published a paper exploring how to create **fair compensation schemes for community health workers** using artificial intelligence.

Our first innovation strategy

This will guide us on how to harness innovation for maximum impact.

Examples of this in practice:

A chatbot with a local partner in Zambia

A prototype of a digital payment system for community health workers in Zanzibar

Design of a direct-to-client solution for Zanzibari mothers, based on the MomConnect platform to be integrated into the national community health system, Jamii ni Afya.

Finally, our engagement with the Fast Healthcare Interoperability Resources (FHIR) in Malawi has positioned us at the forefront of digital health system integration. Insights from this work have strengthened our contributions to the FHIR ecosystem and by collaborating with industry leaders, we are improving its accessibility and effectiveness globally. Our participation in global discussions, including those at the 2023 Global Digital Health Forum, underscores our commitment to leveraging FHIR for smarter, more integrated and impactful health solutions.

USING DATA TO MAKE BETTER
DECISIONS FOR CARE

We work with governments and partners to build capacity for high-impact and ethical use of data to support better decisions that improve care, from the national level to day-to-day service delivery. We strengthen data governance to make data accessible to those who can use it to improve patients’ lives while also respecting patients’ right to privacy.

In Zanzibar, we collaborated with the government to develop and disseminate policies, guidelines and standards for improved data management and governance within the health system. Our efforts have focused on supporting government stakeholders to improve their use of data for operational decision-making, analysis and research while safeguarding the privacy and safety of patients. These guidelines were approved by the government and will officially be integrated into the health system, alongside training, throughout 2024. In Tanzania, we strengthened the Ministry of Health’s ICT unit’s skills around data management and use. **Responsible management of data is key as we foster**

government partners’ ability to maintain, implement, and utilize data from our programs that are now integrated into Tanzania’s national unified community system.

To further accelerate best-in-class data governance in Tanzania and Zanzibar, we facilitated a **government learning exchange** between Kenya and Zanzibar, where the respective Ministries of Health met to discuss best practices, challenges, and learnings around data governance and digital health. These types of peer-to-peer exchanges are invaluable to avoid reinventing the wheel by building on progress already made.

At the district level in Tanzania and Zanzibar, we’ve standardized data review processes and trained health management teams on data utilization. We’ve also provided training for community health workers to understand the importance of quality data collection for improved patient care. Furthermore, we’re exploring how to improve consent processes for health data use to empower patients and ensure accountability.

Additionally, we have continued to contribute to global advocacy by supporting **Transform Health Coalition**’s efforts to develop a global policy framework for data governance and supported their advocacy efforts to increase investment and action for digital health transformation more broadly.

We have defined the next stage in people-centered health, which is going beyond health silos at community or facility level, to think about *continuous, well-coordinated and quality care across service delivery points and throughout a patient's healthcare journey*. We will focus on leveraging the best of artificial intelligence and innovation to enable this digital continuum of care where we work, ensuring that everyone receives the right care, at the right place and right time, as they navigate through different levels of the health system.

All of this has to be done in co-creation with governments, while fostering the policies, systems, financing, and leadership required to sustain impact.

In 2023, we also focused on improving our organizational effectiveness, impact measurement, and building a sustainable financial foundation. We will continue to build on this in 2024, and beyond.

▶ **Defining programmatic impact.**
We embarked on a journey to redefine our approach. We looked at the underlying assumptions, pathways and interventions needed to bring about the change we want to see in the world. Accompanying this, we began to define the core programmatic indicators that will be used to measure the impact of our programs.

▶ **Improving financial sustainability.**
We have developed a plan to shift D-tree's financial revenue from largely restricted, programmatic funding to more flexible funding to allow us to replicate and scale our model of people-centered health systems.

▶ **Strengthening organizational results-based management.**
We have improved our internal systems for performance management and staff development, as well as established a dashboard for key performance indicators that will enable us to steer the success of the organization.

2024 marks D-tree's 20th anniversary and from now, we will be fully embracing our refined approach so that we can accelerate change for those who need it the most and save lives in the countries we work in.

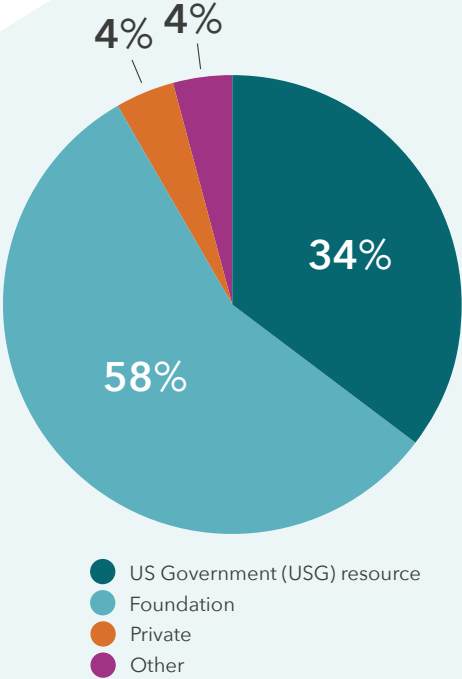

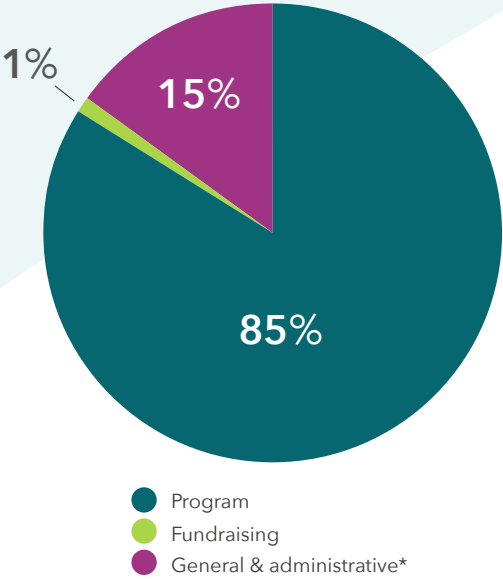
REVENUE BY SOURCE 2023
